

## **Terms & Conditions of Attendance of 1<sup>st</sup> Kiev Clinical Research Forum**

**1. Scope:** the terms and conditions provided in this document apply to all conference attendees.

**2. Attendance:** attending without registration on the conference website and the payment of registration fee is prohibited except for Young Professionals (please refer to the item 3). The registration fee gives access to all the conference sessions, meals and social events. The registration fee does not cover transportation and lodging – this is under attendee's responsibility

**3. Young Professionals:** young professionals in the age under 30 inclusively may attend the conference sessions on a free of charge basis. They will not have access to meals (lunches, gala dinner) and will not be provided with the printing and electronic conference materials.

The eligible young professionals are not supposed to register online. They should email their Bio, passport (ID) and the sessions they would like to attend to [info@pharmasich.com](mailto:info@pharmasich.com). Organisers may turn down the requests like that since the number of young professional delegates is limited.

**4. Speakers (including participants of panel discussions):** speakers are not subject to online registration. They have free access to all meals, sessions, meals and social activities of the conference.

**5. Language:** the working language of the conference is English. The presentations of the Ukrainian Ministry of Health representatives at the Regulatory session will be in a local language – simultaneous translation for the Regulatory Session will be provided.

**6. Video, audio and photo recordings:** the attendees accept that the conference organisers may take their video/photo/audio recordings and use it to highlight the conference in media, on Organisers' websites, emails and with the purpose to promote future Organisers' events.

No conference video/photo/audio recordings are allowed to distribute without prior written approval of Organiser.

**7. Program:** the conference program and speakers may change. The registered attendees will be noticed of the changes as soon as possible.

**8. Marketing activities:** the attendees are prohibited to distribute marketing materials if it has not been approved by Organiser (the exception is to do that in a face-to-face manner).

**9. Cancellation:** all refunds are subject to approval by Organiser. Attendee should send the request by email to [info@pharmasich.com](mailto:info@pharmasich.com) with the explanation of the reason. 35% of the paid registration fee will be refunded if the written notice is received at least 60 calendar days prior to the conference. The other cases of non-attendance are not subject to refund.
